The applicant faxes 'China CCC Mark Annual verification application form of printing / impressing mark permission': <http://china-ccc-certification.com/169.html> with company stamp, copies of CCC certificate and 'Notification of printing / impressing mark permission' to 86-021-51095580-807 or e-mail to ccc#china-ccc-certification.com.
2. If you are not CCC certificate holder, you need fax 'China CCC Mark Annual verification application form of printing / impressing mark permission': <http://china-ccc-certification.com/169.html> with company seal, copies of CCC certificate, 'Notification of printing / impressing mark permission' and 'Trust deed of CCC marks': <http://china-ccc-certification.com/365.html> to 86-021-51095580-807 or e-mail to ccc#china-ccc-certification.com.
3. Please confirm with us to check if the materials are complete and clear after faxing/e-mailing. (Tel: 86-021-51905580-805)
4. We will verify application information. If no problem, we will inform applicant to post us the material in quadruplicate. After receiving that, we will fax / email 'charge notice' to applicant to pay.
5. The applicant fax/email us the remittance certificate after remitting. We will post 'Notification of printing / impressing CCC Mark permission' and 'attached sheet of the notification' to applicant in 7 working days after receiving the complete material and money.
