Process of Purchasing CCC Mark Application:

Applicant of CCC certificate purchase CCC mark by mail or by fax:

1. Send filled 'Application Form for Purchasing CCC Mark' with applicant's seal, duplicate(s) of CCC certificate(s) to ccc#china-ccc-certification.com (all the files mentioned above should be saved as .jpg extension, about 200kb, nominated by serial number of CCC certificate(s).The subject of email should be 'CCC Mark Application'.
2. Applicant which is not the holder of CCC certificate purchasing CCC mark:
Send filled 'Application Form for Purchasing CCC Mark' with holder's seal, duplicate(s) of CCC certificate(s) and commission letter with holder's seal to ccc#china-ccc-certification.com (all the files mentioned above should be saved as .jpg extension, about 200kb,nominated by serial number of CCC certificate(s).The subject of email should be 'CCC Mark Application'.
3. By fax: Please fax the filled 'Application Form for Purchasing CCC Mark' with company seal and signature, and duplicate(s) of CCC certificate(s) and commission letter with holder's seal (if the applicant was not the holder of CCC certificate) to 86-021-51095580-807.
4. After we received the application documents by email or fax, if no problem, we will send 'Charge Notice of CCC Mark' to applicant. Applicant should send the remittance slip back to us by email or fax after payment.
5. After we confirm the charge to account, generally, we will send the CCC mark(s) to applicant in 7 working days by express mail.
