Guideline for China CCC ODM Certification Application for China CCC Certification

1. The applicant fills 'Product Safety China CCC ODM Certification Application Form'. After filling, the applicant faxes it together with business license and organization code certificate to 86-021-51095580-807. (If the applicant, manufacturer and factory are not the same one, then the business license and organization code certificate of the manufacturer and factory should be provided too).
2. After receiving the fax, we will check the information first. If no problem, we will fax/email you file list for applying for ODM CCC certificate:
3. After receiving the formal file, we will fax or email 'Charge Notice in Advance of China CCC Certification' to inform the applicant to pay if no problem. The applicant should fax back remittance note. After confirming that the funds arrive, we will send documents to appointed inspection organization to check.
4. After the inspection organization receives the applying documents, we fax or email 'Charge Notice of China CCC Certification Inspection' to inform the applicant to pay. The applicant should fax back remittance note after remitting. We inform the inspection organization after confirming the funds arrive. If necessary, the applying enterprise should provide sample to take difference test and ODM type testing report to the examining department. (We will fax or email 'Notice of sending samples' to applicant to take sample inspection if necessary).

The examining department will take overall assessment after receiving CCC ODM type test report from inspection organization and other applying documents. CCC ODM certificate will be issued after the assessment is passed.

5. After receiving the valid CCC ODM certificate, applicant must paste CCC mark on the products to sell.

Directions of filling 'Product Safety China CCC ODM Certification Application Form':

1. Name of China CCC Certification Certificate Applicant should be the name of company.
2. China CCC Certification Application applicant and manufacturer must write E-mail. The subject should be 'China CCC Certification Application' (Please save the subject, or we will treat it as junk mail.)
3. It may be added pages if with too many China CCC Certification certificates, too many names and models of Product.
