

## The Process of CCC Certification for CCC Alteration Application(Change of Designs or Standards which Affect the Products Obviously,eg:Safety Component of the Passed Products was Changed)

1.Fill in 'CCC Alteration Application Form': <a href="http://china-ccc-certification.com/225.html">http://china-ccc-certification.com/225.html</a>, with the seal and 'business license' fax to:8621-51095580-807 or e-mail to ccc#china-ccc-certification.com.

- 2.Our office will check all documents, if they are all right, we will fax or e-mail list of documents for CCC alteration for key components: <a href="http://china-ccc-certification.com/178.html">http://china-ccc-certification.com/178.html</a> and related notes.
- a. Chinese/English copy of CCC certificates apply for CCC alteration
- b. 'CCC Alteration Application Form'
- c.Product description reports(standard specification)
- d.Product structure drawings(assembly drawings), electrical diagrams; submit product quality certification qualification of key component suppliers if change of product key components or suppliers (i.e.copy of product inspection reports, copy of product quality safety certification certificates, etc.)
- e.Other documents need to be submitted for CCC alteration application.
- (4 copies of documents above with applicant/manufacturer seal), and send to our office.
- 3.After rechecking the received documents,we will send 'CCC notice charge for CCC alteration application' to applicants(by fax or E-mail);also send 'CCC notice sample sending for CCC alteration application' to applicants(by fax or E-mail) if it is necessary to send sample for confirmation/difference test.
- 4.Applicant should arrange payment according to 'CCC notice charge for CCC alteration application' and fax back 'remittance slip' to:8621-51095580-807 or e-mail to ccc#china-ccc-certification.com.Send sample for inspection according to 'CCC notice sample sending for CCC alteration application' if it is need to sample inspection.
- 5. After we confirm that sample for inspection has been sent in according to related requirements and CCC alteration payment has entered certain account, CCC alteration type test for key component will begin.
- 6. Comprehensive assessment for key component will begin after passing CCC alteration type test.
- 7.Original copy of Alteration Results for CCC China Compulsory Certification Certificate will be issued after passing CCC alteration assessment.
